Notice is hereby given that a special meeting of the Oxford Ridge POA will be held on June 23, 2025 at 3:00pm. The meeting will take place via proxy only with all proxies and ballots due prior to the conclusion of the Special Meeting. All results of the Special Meeting shall be declared the following day by 11:59 p.m. THE BALLOT AND PROXY STATEMENT ARE INCLUDED WITH THIS NOTICE. THESE DOCUMENTS ARE PRINTED FRONT AND BACK ON THE SAME SHEET OF PAPER. THESE DOCUMENTS MUST BE RETURNED PRIOR TO THE SPECIAL MEETING TO BE COUNTED TOWARD A QUORUM FOR THE MEETING AND FOR VOTING.

The purpose of the special meeting is to receive a motion and discuss and conduct a vote to approve the expansion of the Oxford Ridge POA community swimming pool.

More specifically, this meeting will address, receive motions and conduct votes concerning:

- Approval of the contract to expand the Oxford Ridge POA community swimming pool for an estimated cost of \$225,000.00, the proposed estimate will be provided by email separately.
- Approval of utilization of current reserve funds for a down payment toward the Oxford Ridge POA community swimming pool expansion, as discussed above.
- Authorization for the Board to procure financing to obtain the remainder of the funds necessary to complete the Oxford Ridge POA community pool expansion.

The minutes will include the results of any and all votes cast. The Board of Directors may suspend the voting rights of any Member who is not in good standing.
